About Company

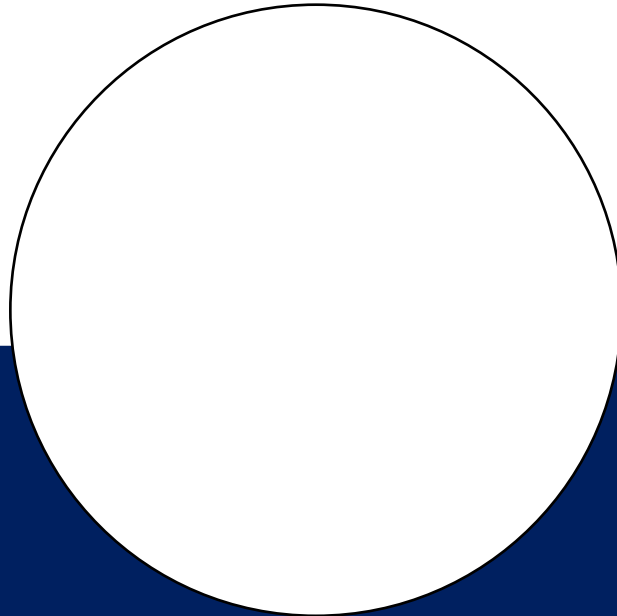
